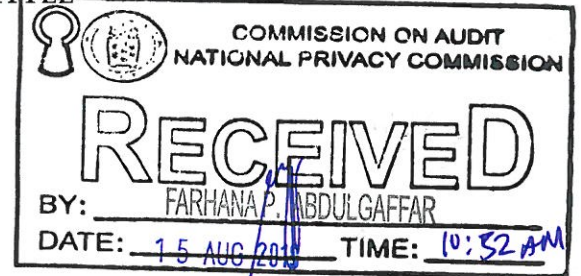





**RECOMMENDING THE AWARD OF CONTRACT FOR THE IN-HOUSE MEALS
FOR THE DATA PROTECTION OFFICERS' BRIEFINGS TO VIA MARE CORP.**

WHEREAS, every year, the National Privacy Commission conducts a series of Data Protection Officers' Briefings which aims to heighten its participants' appreciation of data privacy and protection, to empower them with the knowledge to comply with the Data Privacy Act of 2012, in aid of NPC's mandate to inform and educate the public about data privacy, data protection, and fair information rights and responsibilities, as provided in Section 9.c of the Implementing Rules and Regulations of R.A 10173 or the Data Privacy Act of 2012 by conducting Data Privacy Officer's Briefings;

WHEREAS, the Public Information and Assistance Division (PIAD) as end-user, submitted its purchase request (P.R no. 2019-0091) and terms of reference, proposing the procurement of catering services for NPC's series of briefings from June to November 2019;

WHEREAS, the CY 2019 Annual Procurement Plan (APP) of NPC includes an allocation for the procurement of meals amounting to Php324,000.00 with the mode of procurement as Direct Contracting;

WHEREAS, Section 50 (c) of Republic Act No. 9184 (RA 9184) and its 2016 Revised Implementing Rules and Regulations (IRR) recognizes the use of Direct Contracting or Single Source procurement as a method of procurement of goods of proprietary nature which can only be obtained from the proprietary source or item sold by an exclusive manufacturer or dealer;

WHEREAS, Section 14 of the contract to lease entered into between NPC and PICC provides that the NPC as lessee shall not be allowed to bring in, for large or extraordinary events and celebrations, catered food and beverages inside the leased premises, since the lessor has an exclusive food concessionaire. Accordingly, the Lessee may, as far as practicable, make arrangements with such concessionaire for the food and beverage requirements for its needs;

WHEREAS, based on the available quotation and information/documents gathered, the NPC BAC determined that it is more advantageous to award of the meals requirement of NPC, with the bid price of Via Mare Corp. in the amount of ONE HUNDRED SEVENTY-EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (Php178,800.00);




