# RECOMMENDING THE AWARD FOR THE PROCUREMENT OF LED KIOSK INDOOR OUTDOOR TOUCH SCREEN

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in compliance with NPC's mandate, the NPC organizes various programs needing the procurement of a LED Kiosk Indoor Outdoor Touch Screen under APP Item No. 03-2019-230 with an Approved Budget for the Contract (ABC) amounting to Php200,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184) recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and provided, that in case of Goods, the procurement does not fall under shopping in Section 52 of the RIRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to several suppliers, namely: Wattsavers Energy Services Co., Nyxsys Philippines, Inc., Cubed Technologies Solutions Phils., Inc. and Agard Philippines Inc., with the latter 2 failing to submit their quotations;

WHEREAS, upon seeing the NPC postings, 16/35mm Production Supply likewise submitted its quotation;

WHEREAS, the BAC members proceeded to evaluate the three (3) quotations received and also reviewed the BAC-TWG report submitted stating that only Wattsavers Energy Services Co.'s quotation complied with the technical specification requirements. The BAC then proceeded to evaluate the eligibility documents and determined that Wattsavers Energy Services Co. complied with both the eligibility and technical specifications, submitting the single calculated and responsive quotation at a bid price of Php170,000.00, passing the technical, legal and financial requirements mandated under R.A. 9184;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for

procurement of LED Kiosk Indoor Outdoor Touch Screen to Wattsavers Energy Services Co., with the single calculated and responsive quotation in the total amount of One Hundred Seventy Thousand and 0/100 Pesos (Php170,000.00);
