**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF A PORTABLE
DISPLAY SYSTEM**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, the NPC is mandated to raise awareness regarding data privacy and pursuant to this mandate, the NPC saw it fit to procure a portable display system under APP Item No. 03-2019-232 with an Approved Budget for the Contract (ABC) amounting to Php600,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to four (4) suppliers., namely, Centrex Corporation, Sign Media, Inc., Benew Designs, Inc., and Printixels Enterprise, with only Centrex Corporation submitting a quotation;

WHEREAS, the BAC members proceeded to evaluate the lone quotation and determined that the quotation sent by Centrex Corporation is the single calculated and responsive quotation at a bid price of Php 407,619.80, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of a portable display system to Centrex Corporation, with the single

calculated and responsive quotation in the total amount of Four Hundred Seven Thousand Six Hundred Nineteen and 80/100 Pesos (Php 407,619.80).
