Resolution No. 048-2020, Series of 2020

RECOMMENDING THE APPROVAL OF THE AWARD FOR THE CONTRACT FOR PUBLICATION OF THE NATIONAL PRIVACY COMMISSION'S ISSUANCES

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, pursuant to its mandate, NPC issued two (2) Circulars, namely, the Guidelines on the Processing of Personal Data for Loan-Related Transactions and Data Sharing Agreements;

WHEREAS, in order for the Circulars to have force and effect, there is a need to publish the same in three (3) newspapers of general circulation under APP Item No. 2020-0002 with an Approved Budget for the Contract (ABC) amounting to Php480,000.00;

WHEREAS, Section 53.6 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Negotiated Procurement for Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as a method of procuring goods;

WHEREAS, the end-user submitted the result of the Market Study conducted prior to the commencement of this procurement process, herein attached as Annex "A". The study provided for a list of possible providers that can perform the project based on the required technical specifications;

WHEREAS, among the list of providers in the Market Study, the NPC Bids and Awards Committee (BAC) determined that Philippine Daily Inquirer, Philippine Star, and Daily Tribune are technically, legally and financially capable to undertake the project at the most advantageous terms to the NPC;

WHEREAS, the NCP BAC undertook the negotiations with Philippine Daily Inquirer, Philippine Star, and Daily Tribune based on the Technical Specifications, Scope of Work or Terms of Reference prepared by the End-User;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the contract of

publication in the total amount of Four Hundred Six Thousand Seven Hundred Sixteen and 80/100 (Php 406,716.80), broken down into the following:
