**RECOMMENDING THE AWARD FOR THE ENGAGEMENT OF SERVICE FOR
THE PRINTING OF 2019 COMPENDIUM**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, pursuant to its mandate to inform and educate the public about data privacy, NPC saw it fit to procure service for the printing of 2019 NPC Compendium under APP Item No. 2020-0004 with an Approved Budget for the Contract (ABC) amounting to Php550,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to five (5) suppliers, three (3) of whom submitted their quotations, namely: Innovation Printshoppe, Inc., Kayumanggi Press Inc. and Gorilla Trading, all of which were found eligible;

WHEREAS, the BAC members proceeded to evaluate the submitted quotations and determined that the lowest calculated and responsive quotation belongs to Kayumanggi Press Inc. at a bid price of Php315,000.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the engagement of service for the printing of 2019 Compendium to **Kayumanggi Press Inc.**

with the lowest calculated and responsive quotation in the total amount of **Three Hundred Fifteen Thousand and 0/100 Pesos (Php315,000.00)**.




