RECOMMENDING THE APPROVAL OF THE AWARD FOR THE PROCUREMENT OF INTERNET SERVICE/SUBSCRIPTION PROVIDER

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to be able to effectively perform its mandate, NPC should have a reliable internet service/subscription provider;

WHEREAS, the procurement is under APP Item No. 2020-074 with an Approved Budget for the Contract (ABC) amounting to Php340,000.00;

WHEREAS, the Government Procurement Policy Board (GPPB) has issued Resolution No. 019-2006 adopting the guidelines on the procurement of water, electricity, telecommunications and internet service providers;

WHEREAS, pursuant to the provisions of GPPB Resolution No. 019-2006, the management of NPC saw it fit to renew the contract of its current internet service provider, *Converge ICT Solutions, Inc.*, considering that it has satisfactorily met the required technical specifications, minimum quality of service and other deliverables required, as well as having the lowest bid price as detailed under the required Evaluation and Cost Benefit Analysis including a Market Study, herein attached as Annexes "A" and "B";

WHEREAS, based on the Evaluation and the Cost Benefit Analysis submitted, the NPC Bids and Awards Committee (BAC) determined that *Converge ICT Solutions, Inc.* tendered very satisfactory performance and eligible for contract renewal in accordance with GPBB Resolution No. 019-2006.

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the renewal of contract of internet service/subscription provider to Converge ICT Solutions, Inc. with the total amount of Php 289,197.22.
