**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF KAPIHAN
WITH THE COMMISSIONER (CUSTOMIZED JACKET)**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, one of NPC's mandate is to raise public awareness regarding data privacy. Thus, the NPC saw it fit to procure Kapihan with the Commissioner (customized jacket) under APP Item No. 2020-0159 with an Approved Budget for the Contract (ABC) amounting to Php325,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to three (3) suppliers, namely, Ceboom Enterprises, MGCP Marketing and Karen International, Inc., with only the latter failing to submit its quotation;

WHEREAS, the BAC members proceeded to evaluate the quotations of Ceboom Enterprises and MGCP Marketing and determined that MGCP Marketing failed to submit its Omnibus Sworn Statement, leaving Ceboom Enterprises as the bidder with the single calculated and responsive quotation at a bid price of Php 315,000.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC-BAC hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award for the procurement of Kapihan with the Commissioner (customized jacket) to **Ceboom**

Enterprises with the single calculated and responsive quotation in the total amount of **Three Hundred Fifteen Thousand and 0/100 Pesos (Php315,000.00)**.


