**RECOMMENDING THE APPROVAL OF THE AWARD FOR THE ENGAGEMENT
OF CONTRACT FOR THE PROCUREMENT OF CAMERA DEHUMIDIFYING
CABINET**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to be able to effectively perform its mandate, NPC uses digital equipment that needs to be protected from moisture, moth, mildew, rust, dust, mold, fungus and oxidation among others;

WHEREAS, in order to protect the digital equipment of the Commission, the management of NPC saw it fit to procure a Camera Dehumidifying Cabinet under APP Item No. 03-2019-231 with an Approved Budget for the Contract (ABC) amounting to Php60,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, based on the quotation submitted, the NPC Bids and Awards Committee (BAC) determined that Vitara Marketing submitted the single calculated and responsive quotation;


