**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF PVC PRINTER
(COLORED, DUAL SIDED PRINTER AND WITH ID MAKER SOFTWARE)**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, there is a need control the access to data necessitating the procurement of PVC Printer (colored, dual sided printer and with ID maker software) under APP Item No. 03-2019-226 with an Approved Budget for the Contract (ABC) amounting to Php160,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to several suppliers, namely: Philcopy Corporation, MEGAKARTE Smartcard Corporation, Crystal Image Paper Marketing Corporation and BayanPC Technologies Inc. However, the latter 3 failed to submit their quotations. Thus, Philcopy Corporation was joined by Shmic General Merchandise, Allcard Inc., Gakken Philippines Inc.;

WHEREAS, the BAC members proceeded to evaluate the quotations. However, Shmic General Merchandise, Allcard Inc. and Gakken Philippines Inc. failed to comply with the technical requirements, based on the BAC-TWG Report attached as ANNEX "A", leaving Philcopy Corporation with the single calculated and responsive quotation at a bid price of Php93,420.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for procurement of PVC Printer (colored, dual sided printer and with ID maker software) to

Philcopy Corporation, with the single calculated and responsive quotation in the total amount of Ninety-three Thousand Four Hundred Twenty and 0/100 Pesos (Php93,420.00).






