**RECOMMENDING THE APPROVAL OF THE AWARD FOR THE ENGAGEMENT
OF CONTRACT FOR THE PROCUREMENT CUSTOMIZED JACKETS -
PRIVAMOVES**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to be able to effectively perform its mandate, NPC launched the Privacy Safety Security and Trust Online (PSST!) in order to raise awareness on the value of online security and data protection;

WHEREAS, in order to instill better retention of the event, NPC saw it fit to procure customized jackets as promotional material under APP Item No. 03-2019-184 with an Approved Budget for the Contract (ABC) amounting to Php360,000.00;


WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, based on the quotation submitted, the NPC Bids and Awards Committee (BAC) determined that Ceboom Enterprises submitted the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of the contract for the procurement of customized jacket to *CEBOOM ENTERPRISES* with the lowest calculated and responsive quotation in the total amount of Php316,500.00.
