**RECOMMENDING THE AWARD FOR ENGAGEMENT OF SERVICES FOR  
PEST CONTROL**

**WHEREAS**, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

**WHEREAS**, in order to maintain in good condition the offices of the NPC, the management saw it fit to procure the services of a pest control provider under APP Item No. 2020-0118;

**WHEREAS**, Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as "Government Procurement Reform Act" allows for an alternative method of procurement through Small Value Procurement when the amount involved does not exceed the thresholds prescribed in Annex "H" of R.A. 9184's IRR;

**WHEREAS**, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to four (4) suppliers: Top Notch Pest Control, Mr Pest Control, Calf Tech Pest Control and Power House Pest Control Services where only the latter submitted its quotation and the other one is D-Three Pest Management Services;

**WHEREAS**, the BAC members proceeded to evaluate the submitted quotations and determined that D-Three Pest Management Services has the lowest calculated and responsive quotation at a bid price of Php20,000.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the members of the NPC-BAC hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award for the procurement of pest control services to **D-Three Pest Management Services** in the total amount of **Twenty Thousand and 0/100 Pesos (Php20,000.00)**.



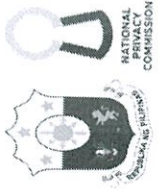
