Resolution No. 086-2020, Series of 2020

### RECOMMENDING THE AWARD FOR THE PROCUREMENT OF VAW POLO SHIRT AND CAP

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, all government agencies are mandated to observe the 18-day Campaign to End Violence Against Women (VAW) and in order to raise awareness against VAW, NPC saw it fit to procure VAW Polo Shirt and Cap under APP Item No. 2020-0105 with an Approved Budget for the Contract (ABC) amounting to Php175,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement (SVP) as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to five (5) suppliers. Out of the five suppliers to whom the RFQs were sent, only Ceboom Enterprises submitted its quotation. Two (2) others submitted their quotations, namely; Rulujac Enterprise and Veraliz Marketing, however, of the three (3) that submitted quotations, Veraliz Marketing failed to submit an updated Omnibus Sworn Statement leaving two (2) bidders eligible.

WHEREAS, the BAC members proceeded to evaluate the submitted bids and determined that the lowest calculated and responsive quotation belongs to Ceboom Enterprises at a bid price of Php86,400.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of VAW Polo Shirt and Cap to Ceboom Enterprises with the lowest calculated and responsive quotation in the total amount of Eighty-six Thousand Four Hundred and 0/100 Pesos (Php86,400.00).
