RECOMMENDING THE APPROVAL OF THE POST QUALIFICATION EVALUATION REPORT AND THE AWARD OF CONTRACT FOR THE PROCUREMENT OF A TEN (10)-MONTH SECURITY SERVICES CONTRACT FOR THE NATIONAL PRIVACY COMMISSION (NPC)

WHEREAS, on 16 June 2020, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) held the bid opening and evaluation of bids for the procurement of a ten (10)-month security services contract for the NPC;

WHEREAS, upon evaluation of the technical and financial component of the submitted bids in accordance to the provisions of the Implementing Rules and Regulations (IRR) of R.A. 9184 otherwise known as the Government Procurement Reform Act, it was determined that the lowest responsive bid is ONE MILLION EIGHT HUNDRED FIFTY-SEVEN THOUSAND EIGHT HUNDRED THIRTY-SEVEN PESOS AND SIX CENTAVOS (Php1,857,837.06) by *Grand Meritus Security Agency, Inc.*;

WHEREAS, the BAC Secretariat then proceeded to forward the bid documents to the BAC Technical Working Group (TWG) for post-qualification evaluation;

WHEREAS, after verifying, validating, and ascertaining all statements made and documents submitted by the bidder, the TWG, in its Post Qualification Evaluation Report, Supplemental Post Qualification Report and Recommendation of Award herein attached as Annexes "A", "B" and "C", was able to conclude that *Grand Meritus Security Agency, Inc.* complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, that pursuant to the Post Qualification Evaluation Report, Supplemental Post Qualification Report and Recommendation of Award herein attached as Annexes "A", "B" and "C, hereby recommends the award of contract relative to the procurement of a ten (10)-month

security services contract for NPC to *Grand Meritus Security Agency, Inc.* as the lowest calculated responsive bid (LCRB);


