**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
ADVOCACY TOKENS TO YEKEL TRADING**

WHEREAS, pursuant to Presidential Proclamation Nos. 224 and 227 and Republic Act No. 6949 otherwise known as “An Act to Declare the First Week of March of Every Year as Special Working Holiday to be Known as National Women’s Day”, the National Privacy Commission (NPC), is among the government agencies and instrumentalities mandated to encourage and afford sufficient time and opportunities for their employees to engage and participate in activities conducted to celebrate National Women's Day;

WHEREAS, to aid NPC in that purpose, the Gender and Development, Focal Point System-Technical Working Group (GAD FPS-TWG) as end-user, proposed the procurement of Advocacy Tokens to be distributed for the abovementioned event, per Purchase Request No. 2020-0014 as approved by the Head of the Procuring Entity (HoPE) with an Approved Budget for the Contract (ABC) amounting to PHP130,000.00 under APP Item No. 2020-S1-005 with Small Value Procurement (SVP) as the mode of procurement;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 also known as the “Government Procurement Reform Act”, recognizes SVP as a mode of procurement for goods where the amount does not exceed One Million Pesos (PHP1,000,000.00) and not covered by the alternative mode of Shopping under Section 52 of RA No. 9184 and its IRR;

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on 22 February 2020 the Request for Quotations (RFQs) in the Philippine Government Electronic Procurement System (PHILGEPS), the NPC website and bulletin board, and sent RFQs through electronic mail to various suppliers. Among the suppliers who responded were Silent Worker Marketing, ACSAN Enterprise, and Yekel Trading;

WHEREAS, upon the deadline for submission of quotation on 26 February 2020, the NPC-BAC Secretariat opened the quotations received and proceeded to evaluate the compliance of the offers against the necessary legal, technical, and financial requirements;


WHEREAS, based on the results of the evaluation, a copy of which is attached as Annex “A”, the NPC-BAC determined that Yekel Trading tendered the Single Calculated and Responsive Quotation in the amount of One Hundred Twelve Thousand Sixty-Five Pesos (PHP112,065.00);




