RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF CORPORATE JACKET AND POLO SHIRT TO CEBOOM ENTERPRISES

WHEREAS, the National Privacy Commission (NPC), the implementing agency of Republic Act No 10173 otherwise known as the Data Privacy Act of 2012, is steadfast in protecting the Filipino citizens' right to data privacy and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, pursuant to Presidential Proclamation Nos. 224 and 227 and Republic Act 6949 "An act to declare the first week of March of every year as special working holiday to be known as National Women's Day", the NPC joins the celebration to support the government's international commitments on gender and development and promote and advocate women's rights and in commemoration of the struggle of Filipino women for national independence, civil liberty, and human rights;

WHEREAS, to aid NPC in that purpose, the Gender and Development, Focal Point System-Technical Working Group (GAD FPS-TWG) as end-user proposed the procurement of corporate jacket and polo shirt for the aforesaid event, per Purchase Request No. 2020-0013 as approved by the Head of the Procuring Entity (HoPE) with an Approved Budget for the Contract (ABC) amounting to PHP250,000.00 under APP Item No. 2020-S1-004 with Small Value Procurement (SVP) as the mode of procurement;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 also known as the "Government Procurement Reform Act," recognizes SVP as a mode of procurement for goods where the amount does not exceed One Million Pesos (PHP1,000,000.00) and not covered by the alternative mode of Shopping under Section 52 of RA 9184 and its IRR;

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on 20 February 2020 the Request for Quotations (RFQs) in the Philippine Government Electronic Procurement System (PHILGEPS), the NPC website and bulletin board, and sent RFQs through electronic mail to Ceboom Enterprises, Tanjer Enterprises and, Sebenknows;

WHEREAS, upon the deadline for submission of quotation on 24 February 2020, the NPC-BAC Secretariat opened the quotations received, both solicited and unsolicited, and proceeded to evaluate the compliance of the offers against the necessary legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached as Annex "A," the NPC-BAC determined that CEBOOM Enterprises tendered the Lowest Calculated and Responsive Quotation in the amount of ONE HUNDRED SEVENTY-EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (PHP178,400.00);


NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of Corporate Jacket and Polo Shirt to **CEBOOM ENTERPRISES** in the total amount of PHP178,400.00.




