RECOMMENDING THE AWARD OF PROCUREMENT FOR PRINTING OF THE STANDARD OPERATING PROCESS (SOP) OF ASD

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, in order to effectively help the NPC in achieving its objectives, the ASD, being one of the divisions of the NPC saw it fit to procure the printing of its Standard Operating Process under APP Item No. 2020-0021 with an Approved Budget for the Contract (ABC) amounting to Php40,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procurement where-the-amount-involved-does-not-exceed-the-threshold-prescribed-in-Annex "H" of the IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to several suppliers however no quotation was received, the post was then extended and again was sent to four (4) suppliers, namely, Kayumanggi Press Inc., Printcore, Inc., Innovation Printshoppe, Inc. and Gorilla Trading with all of them failing to submit its quotation except the latter;

WHEREAS, the BAC members proceeded to evaluate the quotation submitted by Gorilla Trading and determined that its quotation is the single calculated and responsive quotation at a bid price of Php40,000.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the printing of ASD's Standard Operating Process to Gorilla Trading with the single

calculated and responsive quotation in the total amount of Forty Thousand and 0/100 Pesos (Php40,000.00).
