**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF CULMINATING
ACTIVITY SEMINAR ON SOGIE LAW: ADVOCACY TOKENS**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, all government agencies are mandated to observe the 2021 National Women's Month Celebration and conduct a series of activities aimed at highlighting the extraordinary roles of women in the society;

WHEREAS, in support of this objective, NPC saw it fit to procure travel organizers, cotton canvas tote bags, customized magic coffee mugs, and transparent spray bottles as advocacy tokens for the Culminating Activity Seminar on SOGIE Law under APP Item No. 2021-0095 with an Approved Budget for the Contract (ABC) amounting to Php160,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of the IRR;

WHEREAS, a Request for Quotation was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to three suppliers, namely: Veraliz Marketing, Rulujak Enterprises and CEBOOM Enterprises.

WHEREAS, out of these three suppliers to whom the RFQ were sent, only CEBOOM Enterprises complied. Another supplier, AVECILLA Trading, also sent its quotation but it failed to submit a copy of its expired Business or Mayor's Permit which is required to be presented together with the Official Receipt renewing the same as mandated by GPPB Resolution No. 09-2020, leaving only one (1) eligible bidder;

WHEREAS, on 19 March 2021, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation by CEBOOM Enterprises and determined that it has passed the technical, legal, and financial requirements mandated under R.A. No. 9184 and its IRR, making it the single calculated and responsive quotation at a bid price of Php155,215.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Culminating Activity for SOGIE Law: Advocacy Tokens to **CEBOOM Enterprises** for having the

single calculated and responsive quotation in the total amount of **One Hundred Fifty-five Thousand, Two Hundred and Fifteen and 0/100 (Php155,215.00)**.




