**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF POLO T-SHIRTS
AND CAPS FOR THE CULMINATING ACTIVITY SEMINAR ON SOGIE LAW**

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, all government agencies are mandated to observe the 2021 National Women's Month Celebration and conduct a series of activities aimed at highlighting the extraordinary roles of women in the society;

WHEREAS, in support of this objective, NPC saw it fit to procure polo t-shirts and caps for the Culminating Activity Seminar on SOGIE Law under APP Item No. 2021-0094 with an Approved Budget for the Contract (ABC) amounting to Php120,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 otherwise known as the Government Procurement Reform Act (R.A. 9184) recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the revised IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to four suppliers, namely, Veraliz Marketing, Rulujak Enterprises, Berachah Advertising Services and CEBOOM Enterprises, all of which failed to submit their respective quotations except the latter;

WHEREAS, on 31 March 2021, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation by CEBOOM Enterprises and determined that it has passed the technical, legal, and financial requirements mandated under R.A. No. 9184 and was determined to be the single calculated and responsive quotation at a bid price of Php116,365.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award for the procurement of Polo T-shirts and Caps for the Culminating Activity for SOGIE Law to **CEBOOM Enterprises** for having the single calculated and responsive quotation in the total

amount of **One Hundred Sixteen Thousand, Three Hundred and Sixty-Five and 0/100 Pesos (Php116,365.00)**.




