Resolution No. 083-2020, Series of 2020

### RECOMMENDING THE AWARD FOR THE ENGAGEMENT OF PRINTING SERVICE FOR PRIVACY TOOL KIT

WHEREAS, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

WHEREAS, pursuant to its mandate to inform and educate the public about data privacy, NPC saw it fit to procure service for the printing of Privacy Tool Kit under APP Item No. 2020-0013 with an Approved Budget for the Contract (ABC) amounting to Php250,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to five (5) suppliers who all failed to submit their quotations except Kayumanggi Press Inc. Aside from the latter, there are three (3) others who submitted their quotations, namely: AG3 Colors Printing Press, King Phil Printing Services, and Visual Color, Inc.;

WHEREAS, the BAC members proceeded to evaluate the submitted quotations and of the four, King Phil Printing Services and AG3 Colors Printing Press failed the eligibility check. The BAC members then proceeded to evaluate the remaining quotations and determined that Visual Color, Inc. provided the lowest calculated and responsive quotation at the bid price amounting to Php249,350.00., passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the engagement of printing service for the Privacy Tool Kit to **Visual Color, Inc.** with the

lowest calculated and responsive quotation in the total amount of Two Hundred Fortynine Thousand, Three Hundred and Fifty Pesos and 0/100 Pesos (Phph249,350.00).
