# RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF JACKET, CUSTOMIZED

WHEREAS, the National Privacy Commission (NPC), approved its FY 2021 Annual Procurement Plan (APP) which includes the procurement of jackets, customized under APP Item Number 2021-0117 and chargeable against Other Supplies and Materials Expenses (OPERATIONS-MOOE) with an Approved Budget for the Contract (ABC) of Php325,000.00;

WHEREAS, the procurement of jackets is intended to solidify the connection between the attendees and the NPC as organizers of this year's Privacy Awareness Week (PAW) celebration:

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 27 April 2021, and was likewise sent to three (3) suppliers via electronic mail, namely: Veraliz Marketing, Ceboom Enterprises, and Rulujak Enterprises, but the latter failed to submit. Another bidder, Zioneyes General Merchandise, also submitted a quotation;

WHEREAS, on 05 May 2021, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that among the three (3) suppliers who made their submission, only Zioneyes General Merchandise and Ceboom Enterprises were considered as eligible and has passed all the technical, legal, and financial requirements mandated under R.A. No. 9184;

WHEREAS, Ceboom Enterprises has a bid price of Php304,200.00, while Zioneyes General Merchandise has a bid price of Php225,000.00, effectively making the latter as the bidder with the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Jacket, Customized to **Zioneyes General Merchandise** for having the lowest
