BAC Resolution No. 081-2021, Series of 2021

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PROFESSIONAL SERVICE (PCR TEST)

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the provision of RT-PCR test is one of the health protocols established by the NPC's Health and Safety Committee, pursuant to Privacy Commissioner Order No. 003, s. 2021, "Supplemental Guidelines on Health and Safety Protocol and Procedures in Response to COVID-19 Pandemic", to ensure that employees are physically fit to perform his/her function and to prevent transmission of the virus within the workplace;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2021 Appropriations (RA 11520), programmed under the NPC FY 2020 APP Item No. 2020-0200 and with Approved Budget for the Contract (ABC) amounting to Php400,000.00;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 17 August 2021, and was likewise sent to four (4) suppliers via electronic mail, namely: Best Diagnostic Corporation, East Avenue Medical Center, AP Global IT Solutions, and Clearbridge Medical Philippines Inc.;

WHEREAS, three (3) suppliers submitted their quotations, namely: Best Diagnostic Corporation, Clearbridge Medical Philippines, Inc., and Philippine Vision Group (PVG) Inc.;

WHEREAS, Philippine Vision Group (PVG) Inc. failed to submit an Omnibus Sworn Statement, while the Secretary's Certificate submitted by Clearbridge Medical Philippines, Inc. failed to include a proviso authorizing its representative to transact with the NPC;

WHEREAS, Best Diagnostic Corporation complied with all the eligibility requirements and has a bid price of Php336,000.00;
