**RECOMMENDING THE AWARD OF CONTRACT FOR THE
SUPPLY AND DELIVERY OF DAILY NEWSPAPER**

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, to support the NPC's mandate, the Administrative Services Division (ASD) proposed the procurement of Supply and Delivery of Daily Newspaper for the use of NPC officials and employees to ensure that all personnel are informed with facts, statistics, and opinions from columnists which may serve as reference of the Commission in the creation of issuances and other relevant documents that will benefit the data subjects;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2021 Appropriations (RA 11520), programmed under the NPC FY 2021 APP Item No. 2021-0010 and with Approved Budget for the Contract (ABC) amounting to Php60,000.00;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 14 September 2021, and was likewise sent to six (6) suppliers via electronic mail, namely: Jad Twice Print Media Dealer, Nandisco Enterprises Newspaper Subscription Services, Subscription Services, AG3 Colors Printing, VDR Newspaper Delivery, and JJJ Newspapers & Magazines;

WHEREAS, only JJJ Newspapers & Magazines submitted a quotation with a bid price of Php56,535.00 well within the ABC;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the Procurement of Supply and Delivery of Daily Newspaper to **JJJ Newspapers & Magazines** for passing all the required eligibility and for having the single calculated and responsive quotation in the total amount of **Fifty-Six Thousand Five Hundred Thirty-Five and 0/100 Pesos (Php56,535.00)**.






