RECOMMENDING THE AWARD OF CONTRACT FOR NPC WEBSITE REVAMP

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, in line with the Public Information and Assistance Division's (PIAD) function of information management, which includes website maintenance, the Division saw it fit to enhance the existing WordPress website, create a new WordPress website theme, re-arrange the content of the website, add functionality such as Calendar of Events and Search Bar, add user management, and be more informative while using less text content;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2021 Appropriations (RA 11520), programmed under the NPC FY 2021 APP Item No. 2021-0126 and chargeable against ICT Software Subscription (OPERATIONS-MOOE) with Approved Budget for the Contract (ABC) amounting to Php800,000.00;

WHEREAS, this procurement has been approved and cleared by the Department of Information and Communications Technology for procurement under MOOE for the year 2021 by virtue of the DICT clearance letter dated 15 April 2021, attached herein as Annex "A";

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation was posted in the PhilGEPS website, NPC website, and the NPC bulletin board on 03 September 2021, and was likewise sent to seven (7) suppliers via electronic mail, namely: ZEP Network and Data Solution, My Creative Panda Web Design & Development Consultancy Services, MyBusyBee, Inc., PurpleBug, Inc., Thinkbit Solutions, Inc., Swara Sug Media Corporation, and Teqware Corporation, with only the latter failing to submit a bid;

WHEREAS, a total of nine (9) suppliers submitted their quotations, namely; ZEP Network and Data Solution, Thinkbit Solutions, Inc., My Creative Panda Web Design & Development

Consultancy Services, Bentacos Corporation, Swara Sug Media Corporation, MyBusyBee, Inc., Sophie's Information Technology Services, Moodlearning, Inc., and PurpleBug, Inc.;

WHEREAS, only four (4) out of nine (9) passed all eligibility requirements, namely: Thinkbit Solutions Phils., Inc., My Creative Panda Web Design & Development Consultancy Services, MyBusyBee, Inc. and PurpleBug, Inc.;

WHEREAS, among these four eligible bidders, My Creative Panda Web Design & Development Consultancy Services had the lowest calculated and responsive quotation at a bid price of Php688,888.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the NPC Website Revamp to My Creative Panda Web Design and Development Consultancy Services for passing all the required eligibility and for having the lowest calculated and responsive quotation in the total amount of Six Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight and 0/100 Pesos (Php688,888.00).
