SUBJECT: **Procurement of Ten (10)-Month Security Services for the National Privacy Commission (NPC)**

In light of the continuous implementation of the Enhanced Community Quarantine (ECQ) by the National Government against the COVID-19 pandemic which has hampered work both in the public and private sectors, and to guide the bidders with regard to NPC's revised timeline for the procurement of a ten (10)-month security services contract, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) hereby issues this Supplemental/Bid Bulletin amending the schedule of the activities relative to such procurement, to wit:
