#### ANNUAL EMPLOYEES' APPRECIATION DAY: PLAQUES

#### I. BACKGROUND

The National Privacy Commission (NPC) is the country's privacy watchdog: an independent body mandate to administer and implement the Data Privacy Act of 2021 and to monitor and ensure compliance the country with international standards set for data protection. The law was passed in 2012, but it was only in 2016 that the first Privacy Commissioner was appointed, and the secretariat was formed.

In its pursuit of achieving its vision as the world-class regulatory and enforcement agency upholding the right to privacy and data protection while ensuring the free flow of information and commitment to excellence, its workforce have served as the backbone that dedicated their time, and support in realizing its goal. By the end of this challenging year, FY2021, it is the chance of recognize their contribution, dedication, loyalty and hard work to the success of the agency.

In line with the approval of the Policy Guidelines on Awards and Incentives for Service Excellence (PRAISE) of the NPC, all deserving employees will be recognized and rewarded with monetary and non-monetary incentives during the Annual Employees' Appreciation Day, scheduled on Dec 17, 2021.
