#### TERMS OF REFERENCE

#### KN95 DISPOSABLE FACE MASK

#### I. BACKGROUND

The Philippines continues to be under the State of Public Health Emergency until September 2022, due to the coronavirus disease 2019 (Covid-19) pandemic thru Proclamation No. 1218.

On March 16, 2020, President Duterte issued Proclamation 929, declaring a state of calamity all throughout the country for six months due to Covid-19, and Proclamation 1021 released on Sept. 16, 2020, stretched the state of calamity for another year, or until Sept. 12, 2021.

The new proclamation enjoins all government agencies and local government units to continue rendering full assistance to and cooperation with each other and mobilize the necessary resources to "undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of Covid-19."

Pursuant to the said order, the National Privacy Commission (NPC), being a National Government Agency shall continue to provide its services of protecting the data privacy of all Filipinos. During this times, processing of personal information has increased due to the contact tracing measures and COVI-19 vaccination implementation. Thus, the NPC shall remain in action.

Given the necessity to remain in service, employees must be protected from the ill-effects of the virus by observing health and safety protocols, one of which is by using personal protective equipment such as face mask and face shield. As stressed by the Department of Health (DOH), wearing a mask is part of the prescribed minimum health standards to ensure utmost protection from COVID-19. According to studies, wearing masks lowers the chance of transmission by up to 85%, while maintaining a physical distance of one meter reduces the risk of transmission by 80%.

A member of the DOH Technical Advisory Group and Director of the Institute of Molecular Biology and Biotechnology at the National Institutes of Health at the University of the Philippines Manila, Dr. Edsel Salvana, said that the virus is already assumed to be airborne when conducting aerosol generating procedures in hospitals. "This is why our healthcare workers use N95 masks and conduct strict infection prevention and control measures," Health Undersecretary Maria Rosario Sight-Vergeire said during the July 7 Beat COVID-19 Virtual Presser.

However, not all masks provide the same protection. The fit, filter and the number of layers, are all important to consider when choosing which mask to wear. There are many types of masks that can be used to protect ourselves, such as cloth mask, medical procedure masks (surgical masks), and KN95 Masks. There are pros and cons for each type of mask as summarized in the table below (Centers for Disease Control and Prevention (CDC), 2021):

Type of Mask	Cloth Mask	Surgical Mask	KN95 Mask
Pros	Easy to obtain; comfortable; affordable; convenient; washable and reusable; ear loops, tie cords, and nose wires (if available) can usually be adjusted.	Easy to obtain; comfortable; affordable; convenient; disposable (good for situations when the mask may get wet or dirty); nose wires (if available) can be adjusted.	Filter up to 95% of particles in the air (when they meet the right requirements and are not counterfeit/fake, and when proper fit can be achieved).
Cons	Poorly fitting masks may have gaps around the sides of the face or nose. Gaps may allow respiratory droplets containing the virus to leak in and out around the mask. Depending on how they fit and how they are made, cloth masks vary in how well they can protect you and others from getting and spreading COVID-19.	These masks often fit loosely. Masks with ear loops may not be adjustable enough to achieve a better fit. Masks with tie cords can provide a better fit for some people. Poor fit causes gaps around the nose and along the sides of the face where respiratory droplets containing the virus can leak in and out; designed for one-time use.	Can be uncomfortable; often requires more effort to breath; may be more expensive and difficult to obtain; designed for one-time use; many counterfeit (fake) KN95 masks are commercially available, and sometimes it is hard to tell if they meet the right requirements just by looking at them. At least 60% of the KN95 masks evaluated by NIOSH did not meet the requirements that they claim to meet.
	A cloth mask can be layered on top of a medical procedure mask for improved fit and filtration. Using a mask fitter or brace may also help to improve fit.	A medical procedure mask can be layered underneath a cloth mask for improved fit and filtration. However, a medical procedure mask should not be layered underneath a second medical procedure mask. Using a mask fitter or brace may also help to improve fit	It may be hard to achieve a proper fit with certain types of facial hair.

There is also another type of mask available in the market, the NIOSH-42C FR84 (N95), but priority of use for this type of mask is given to healthcare personnel and for other workers who are required to wear them for protection against other hazards. According to CDC, KN95 is preferable in some situations or for some people – especially for situations that require prolonged close contact with people who do not live in the same household, or for people who are at high risk of illness from COVID-19.

The HRDD, in its goal of ensuring the welfare of its employees, proposes to procure KN95 masks.

### II. OBJECTIVES

To procure KN95 facial masks to be provided to all NPC personnel.

- 2. Multi-layer design for excellent protection from particles
- 3. Light weight for greater comfort
- 4. Features with above 95% filtration efficiency
- 5. Must be FDA approved attach FDA registration number in the quotation (Food and Drug Administration Philippines, 2021)
