TERMS OF REFERENCE

FOR THE PROCUREMENT OF DIGITAL CAMERA (INCLUDING DSLR, IF ANY)

I. BACKGROUND

The National Privacy Commission (NPC) is mandated to administer and implement the Data Privacy Act of 2012 (DPA). NPC is also tasked to inform and educate the public on data privacy, data protection and fair information rights and responsibilities as stated in the Section 9.c of the Implementing Rules and Regulations of DPA.

The Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the Commission. In order to fulfill these tasks, the division will develop, implement and organize various activities, programs and projects. Another way for the division to effectively disseminate information is by producing Audio-Visual Presentations (AVPs). In this regard, the division proposes to purchase a digital camera to shoot videos and photos that could be used for various purposes such as AVPs and event coverage.

II. OBJECTIVES

The purpose of acquiring the digital camera is to aid PIAD in promoting data privacy through various multimedia materials such as AVPs. The digital camera will use to shoot videos and photos that could enhance the quality of the AVPs. This also could be used by other divisions for documentation purposes in dispensing their division's mandate and events organized by the Commission.
