TERMS OF REFERENCE

FOR THE PROCUREMENT OF NETWORK ATTACHED STORAGE

I. BACKGROUND

The National Privacy Commission (NPC) is mandated to administer and implement the Data Privacy Act of 2012 (DPA). NPC is also tasked to inform and educate the public on data privacy, data protection and fair information rights and responsibilities as stated in the Section 9.c of the Implementing Rules and Regulations of DPA.

The Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the Commission. To fulfill these tasks, the division will develop, implement, and organize various activities, programs and projects. Another way for the division to effectively disseminate information is by producing educational materials that's posted on NPC's official social media pages and website. In this regard, the division proposes to purchase a Network Attached Storage (NAS) which will store PIAD's digital resources and backups.

II. OBJECTIVES

The purpose of acquiring the NAS is to aid PIAD in storing all its digital resources and backups. This will allow the retrieval of files using a different device and guarantees the availability of resources whenever needed.
