**PROCUREMENT OF SEMI-EXPENDABLE ICT EQUIPMENT/SUPPLIES**

**I. BACKGROUND**

The National Privacy Commission (NPC) is the country's privacy watchdog; an independent body mandated to administer and implement the Data Privacy Act of 2012, and to monitor and ensure compliance of the country with international standards set for data protection.

**II. OBJECTIVES**

These semi-expendable ICT supplies will be used as portable storage device, replacement for unserviceable unit and to upgrade old existing laptops and desktops to improve its performance.
