**SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE BUS RENTAL
FOR NPC STRATEGIC PLANNING FY 2019 TO GOLD LINE TOURS, INC.**

WHEREAS, pursuant to Republic Act No. 10173, otherwise known as the Data Privacy Act of 2012 and its Implementing Rules and Regulations, the National Privacy Commission (NPC) is mandated to inform and educate the public about data privacy, data protection, and fair information rights and responsibilities;

WHEREAS, in accordance with the abovementioned mandate, the National Privacy Commission (NPC) yearly conducts its Strategic Planning Workshop as a systematic tool to continuously enhance its implementation efforts to deliver efficient and effective services and benefits to stakeholders, pursuant to its mandate provided in the Data Privacy Act of 2012;

WHEREAS, to attain said purpose, the Purchase Request (PR) for the engagement of services for the Bus Rental to transport NPC officials and employees to the venue of the intended Strategic Planning FY 2019 was approved by the Head of the Procuring Entity, with the Finance and Planning Management Division (FPMD) as the end-user, as per P.R No. 2018-0140;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of Small Value for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (Php1,000,000.00);


WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat sent Requests for Quotation (RFQ) on September 28, 2018 to Gold Line Tours, Inc., Buena Vista Travel and Tours Transport, Inc. and Hanna Tours Corporation;

WHEREAS, upon the deadline for submission of quotation on October 1, 2018, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;


WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Gold Line Tours, Inc. tendered the Lowest Calculated and Responsive Bid Quotation in the amount of SEVENTEEN THOUSAND FIVE HUNDRED PESOS ONLY (Php17,500.00);

NOW, THEREFORE, for and in for consideration of the foregoing, **WE**, the members of the NPC Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for Bus Rental to "GOLD LINE TOURS, INC." in the total amount of Php17,500.00 to transport NPC officials and employees from office to the venue of NPC Strategic Planning FY 2019;






