

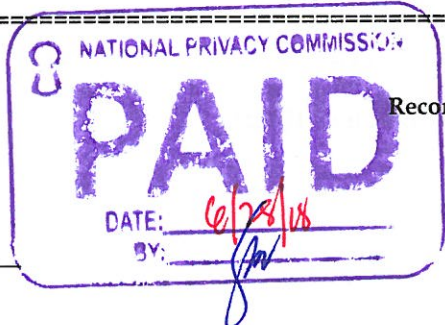

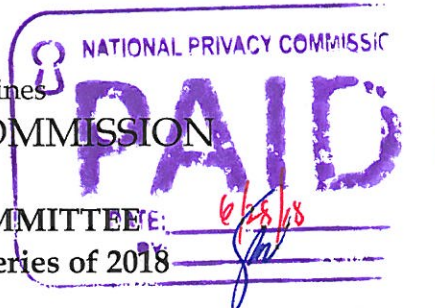

SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE PRODUCTION OF CUSTOMIZED CANVASS TOTE BAGS TO IKF HOME FURNISHING AND OFFICE FURNITURE

WHEREAS, the procurement request for the production of customized canvass tote bags was approved by the Head of the Procuring Entity, with Public Information and Assistance Division (PIAD) as the end-user as per Purchase Request No. 2018-0071;

WHEREAS, the 2018 Annual Procurement Plan (APP) of NPC-PIAD includes an allocation for the production of customized canvass tote bags amounting to Php450,000.00 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 of CY 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of SVP for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on June 9, 2018 the request for quotation (RFQ) in the Philippine Government Electronic Procurement System, NPC Website and bulletin board, and sent RFQs to IKF Home Furnishing and Office Furniture, Kaifashion Philippines, Inc. and Knit and Tuck Merchandising;

WHEREAS, upon the deadline for submission of quotation on June 13, 2018, the NPC BAC Secretariat opened the quotations received, both solicited and unsolicited, and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that IKF Home Furnishing and Office Furniture tendered the Single Calculated and Responsive Quotation in the amount of FOUR HUNDRED FORTY-ONE THOUSAND PESOS ONLY (Php441,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the production of customized canvass tote

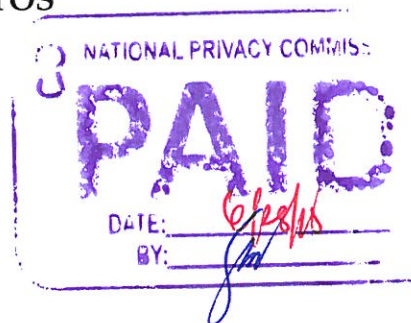
