SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE PRODUCTION OF CUSTOMIZED T-SHIRTS TO SILENT WORKER MARKETING

WHEREAS, the procurement request for the production of customized t-shirts was approved by the Head of the Procuring Entity, with Data Security and Technology Standards Division as the end-user as per Procurement Request No. 2018-0064;

WHEREAS, the 2018 Annual Procurement Plan (APP) of NPC-PIAD includes an allocation for the production of customized t-shirts amounting to Php40,000.00 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of SVP for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (PhP1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat sent the request for quotation (RFQ) on June 11, 2018 to Silent Worker Marketing, Lex-mar General Merchandise and Contractor and IFS Trading;

WHEREAS, upon the deadline for submission of quotation on June 13, 2018, the NPC BAC Secretariat proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Silent Worker Marketing tendered the Single Calculated and Responsive Quotation in the amount of THIRTY-NINE THOUSAND NINE HUNDRED PESOS ONLY (Php39,900.00);
