RECOMMENDING THE AWARD OF CONTRACT FOR THE TOKEN TO PARTICIPANTS IN THE TRAINING ON SELF-DEFENSE AGAINST GENDER-BASED VIOLENCE (CUSTOMIZED T-SHIRTS) TO SILENT WORKER MARKETING

WHEREAS, the National Privacy Commission (NPC) will conduct a project entitled "Lecture Series on Laws Affecting Government Employees and Managing Risk of Lawsuits", one component of the which is the conduct of the seminar on *Training on Self-Defense Against Gender-Based Violence*;

WHEREAS, the Purchase Request (PR) for the Token (Customized T-shirts) for participants in the Training on Self-Defense Against Gender-Based Violence was approved by the Head of the Procuring Entity, with the Legal Division as the End-User, as per P.R. No. 2019-0019;

WHEREAS, the NPC Annual Procurement Plan for 2019 includes an allocation for said activity with an Approved Budget for the Contract amounting to Php15,000.00, with Small Value Procurement as the mode of procurement;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes the use of Small Value Procurement as an alternative method of procurement where the amount does not exceed One Million Pesos (Php1,000,000.00) and the goods is not covered by Shopping under Section 52 of RA No. 9184 and its IRR;

WHEREAS, the NPC Bids and Awards Committee (BAC), through its Secretariat, sent Request for Quotations (RFQs) on 1 March 2019 to Silent Worker Marketing, Tanjer Enterprise & Jastra Corp.;

WHEREAS, the NPC-BAC Secretariat proceeded to evaluate the compliance of the offers to the legal, technical, and financial requirements as provided under the same IRR, only Silent Worker Marketing was able with comply to the requirements;


WHEREAS, based on the result of the evaluation, a copy of which is attached hereto as Annex "A", the NPC-BAC determined that SILENT WORKER MARKETING tendered the Single Calculated and Responsive Quotation in the amount of Fourteen Thousand Nine Hundred Pesos (Php14,900.00);


