**Invitation to Bid for One (1) Lot Procurement of Brand New and Branded Motor Vehicles:**  
**Five (5) Units of Multipurpose Vehicles,**  
**Four (4) Units Asian Utility Vehicle and One (1) Unit Passenger Van**

The **National Privacy Commission (NPC)**, through the authorized appropriations under the **FY 2017 General Appropriations Act** intends to apply the sum of **Ten Million Four Hundred Thousand Pesos (PhP10,400,000.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **Supply and Delivery of Brand New and Branded Motor Vehicles**. Bids received in excess of the **ABC** shall be automatically rejected at bid opening.

The NPC now invites bids for Supply and Delivery of **one (1) lot procurement of Motor Vehicles - Five (5) Units Multipurpose Vehicles, Four (4) Units Asian Utility Vehicle and One (1) unit Passenger Van**. Delivery of the **Goods** is required within sixty (60) calendar days after the issuance of the **Notice to Proceed**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the **Bidding Documents**, particularly, in **Section II of the Instructions to Bidders**.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the **2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184)**, otherwise known as the "**Government Procurement Reform Act**".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines

Interested bidders may obtain further information from NPC and inspect the Bidding Documents at the address given below during office days between **8:00 A.M. and 5:00 P.M.**

A complete set of **Bidding Documents** may be purchased by interested **Bidders** on **August 23 to September 12, 2017** from the address below and upon payment of a non-refundable fee for the **Bidding Documents** in the amount of Twenty-Five Thousand Pesos (PhP25,000.00).

It may also be downloaded free of charge from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and the website of the NPC, provided that Bidders shall pay the nonrefundable fee for the **Bidding Documents** not later than the submission of their bids.

The NPC will hold a **Pre-Bid Conference** on **August 31, 2017 at 2:00 P.M. (PST)** Meeting Room 1, 2<sup>nd</sup> Floor, Core G, GSIS Headquarters Bldg., Financial Center Area, Pasay City, Metro Manila, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below **on or before 12:00 noon, September 12, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be at **2:00 P.M. (PST), September 12, 2017** at Level 3 Lobby, Core G, GSIS Headquarters Bldg., Financial Center Area, Pasay City, Metro Manila. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The NPC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders
