**Invitation to Bid for the Supply, Delivery and Installation of One (1) Lot Procurement
of Landline Subscription for the National Privacy Commission**

The **National Privacy Commission (NPC)**, through the authorized appropriations under the **FY 2018 General Appropriations Act** intends to apply the sum of **Six Hundred Fifty Thousand Pesos (Php650,000.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **Landline Telephone Subscription**. Bids received in excess of the **ABC** shall be automatically rejected at bid opening.

The **NPC** now invites bids for the **supply, delivery, and installation of one (1) lot Landline Subscription for the National Privacy Commission**. Delivery of the services is required within **thirty days (30)** after the issuance of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II of the Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a nondiscretionary “pass/fail” criterion as specified in the **2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184)**, otherwise known as the “**Government Procurement Reform Act**”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines

Interested bidders may obtain further information from **NPC** and inspect the Bidding Documents at the address given below during office days between **8:00 A.M. and 5:00 P.M.**

A complete set of Bidding Documents may be purchased by interested Bidders on **03 August 2018 (Friday)**, from the address below and upon payment of a nonrefundable fee for the **Bidding Documents** in the amount of One Thousand Pesos (Php1,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the NPC, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The **NPC** will hold a **Pre-Bid Conference** on **13 August 2018 (Monday)** at **2:00 P.M. (PST)**, 5th Floor East Banquet Hall, Delegation Building, PICC Complex, Roxas Boulevard, Pasay City, which shall be open to prospective bidders.

A blue handwritten mark, possibly a signature or initials, is located in the bottom right corner of the page.

Bids must be duly received by the BAC Secretariat at the address below **on or before 12:00 NN (PST), 28 August 2018 (Tuesday)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


Bid opening shall be at **2:00 P.M (PST), 28 August 2018 (Tuesday)** at the 5th Floor, East Banquet Hall, Delegation Building, PICC Complex, Roxas Boulevard, Pasay City. Bids will be opened in the presence of the Bidders' representative(s), who choose to attend at the address below. Late bids shall not be accepted. Only persons duly authorized through Board Resolution/Secretary's Certificate shall be allowed to submit and attend the Opening of Bids.

The NPC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
