**SUBJECT: RECOMMENDING THE AWARD FOR THE PRIVACY AWARENESS
WEEK EVENT ORGANIZER TO ONE TOUCHPOINT MEDIA
CONVERGENCE, INC.**

WHEREAS, the procurement request (PR) for the engagement of services of an Event Organizer for the Privacy Awareness Week Program was approved by the Head of the Procuring Entity, with the Office of the Privacy Commissioner (OPC) as the end-user, as per P.R No. 2018-0041;

WHEREAS, the revised 2018 Annual Procurement Plan (APP) of NPC-OPC includes an allocation for the Privacy Awareness Week Event Organizer amounting to Php855,000.00 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 of CY 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognize the use of SVP) for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (PhP1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on May 4, 2018 the request for quotation (RFQ) in the Philippine Government Electronic Procurement System, NPC Website and bulletin board, and sent RFQs to One Touchpoint Media Convergence, Inc., Business Unusual Media Solutions, Inc. and Kinetix Creations;


WHEREAS, upon the deadline for submission of quotation on May 8, 2018, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that One Touchpoint Media Convergence, Inc. the Single Calculated and Responsive Quotation in the amount of EIGHT HUNDRED FIFTY THOUSAND ONE HUNDRED SIXTY-SEVEN PESOS AND FOURTEEN CENTAVOS ONLY (Php850,167.14);

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**,





MEMORANDUM OF AGREEMENT

This is to formalize the partnership agreement between **NATIONAL PRIVACY COMMISSION** (referred to as **NPC**) and **One Touchpoint Media Convergence, Inc.**(referred to as "AGENCY") with regard to the 1st Data Privacy Conference, hereby referred to as the "**EVENT**", to be held at the Plenary Hall, Summit Hall C&D, Meeting Room 1 and 12 from May 28-29, 2018.

One Touchpoint Media Convergence, Inc shall be represented by **Anna Kathrina A. Ocampo**, while National Privacy Commission shall be represented by **Mr. Raymund Enriquez Liboro, Privacy Commissioner**.

The details of this MOA are as follows :

NPC agrees to:

1. Provide payment of Eight Hundred Fifty Thousand One Sixty Seven and Fourteen Centavos (Php 850,167.14) net of taxes.
 - a. Terms of payment:
 - 15%DP upon submission of activity plan
 - 35% upon submission of pre-event report and execution plan
 - 50% FULL PAYMENT upon submission of official documentation of the Conference (photos & videos), Completion of required documents, completion report and Certificate of Acceptance of Output.
 - b. All collection and payments will be payable to One Touchpoint Media Convergence, Inc.

In return, One Touchpoint Media Convergence, Inc. will provide the following services during event, details of which are provided in the attached Terms of Reference:

- Provide Events' Registration and Ushering Management Services
- Events' Technical, Logistics and Production Services
- Overall programs' management assistance

NPC may terminate this agreement with or without cause upon 7 days written notice to Agency. In the avoidance of doubt, the failure of the agency to address bad publicity and/or involvement of the agency in any anomaly which impacts negatively on Client's image shall be considered as breach or violation of the terms and conditions of this contract on the part of the promoter and shall entitle the NPC to terminate this contract effective immediately.

The Agency shall be exclusively liable for any violation of municipal ordinances, national laws, and executive orders, etc., that may be committed by its employees.

Agency shall indemnify and hold harmless the NPCI and its affiliated, agents and employees from and against any all claims, losses, actions, damages, expenses, and all other liabilities, including but not limited to reasonable attorney's fees, arising out of services performed by Agency for NPC or for any damage that may arise in connection with this event. The Agency shall also reimburse NPC for any damage, cost and/or





expenses that the latter may suffer as a result of any action or complaint filed in connection with, or arising from, the holding of these events under agreement. NPC shall give prompt notice to Agency of any such claim, loss, action, damage, expense, or other liability, and shall fully cooperate in the defense of any such action.

The Agency further warrants that NPC shall in no case be liable for death, accident of injury of any kind which may befall its workers during the time or as a consequence of the performance of the services as herein provided, or for any injury, loss or damage to any third persons of their property arising from the acts and/or omissions of the Agency, its workers and representative, nor for any claim, liability, civil or criminal, pertaining to taxes or fees for permits, under relevant laws and regulations in relation to the Agency's own account. The Agency warrants holding NPC free and harmless from any liability or claim made in connection with any of the said circumstance.
