RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF AV SYSTEM RENTAL FOR THE PRIVAMOVES PSST REGIONAL EVENT (ZAMBOANGA) TO IVT GENERAL MARKETING

WHEREAS, the National Privacy Commission (NPC), pursuant to its mission to be the authority on data privacy and protection, providing knowledge, knowhow and relevant policy advice pertaining to technology, programmed the Privamoves PSST Regional Event in Zamboanga to inform and educate the public about data privacy, data protection, and fair information rights and responsibilities;

WHEREAS, the Purchase Request (PR), for the procurement for AV System rental, was approved by the Head of the Procuring Entity, with the Public Information and Assistance Division (PIAD) as the End-User, as per P.R. No. 2019-015;

WHEREAS, the NPC Annual Procurement Plan for 2019 includes an allocation for the procurement of said item amounting Php70,000.00, with Small Value Procurement as the mode of procurement;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes the use of Small Value Procurement as an alternative method of procurement where the amount does not exceed One Million Pesos (Php1,000,000.00) and the goods is not covered by Shopping under Section 52 of RA No. 9184 and its IRR;

WHEREAS, the NPC Bids and Awards Committee (BAC), through its Secretariat, posted the Request for Quotations (RFQs) on PhilGEPS website on 23 February 2019, and sent the same to IVT General Marketing, Unibersidad de Zamboanga, Cross Phil Video Alternatives;

WHEREAS, the NPC-BAC Secretariat proceeded to evaluate the compliance of the offer to the legal, technical, and financial requirements as provided under the same IRR, only IVT GENERAL MARKETING was able to comply to the requirements;

WHEREAS, based on the result of the evaluation, a copy of which is attached hereto as Annex "A", the NPC-BAC determined that IVT GENERAL MARKETING tendered the Single Calculated and Responsive Quotation in the amount of Seventy Thousand Pesos (Php70,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC-BAC, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract to IVT GENERAL MARKETING in the amount of Seventy Thousand Pesos (Php70,000.00);
