**SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE
PRINTING OF NPC COMPENDIUM 2017 TO GORILLA TRADING**

WHEREAS, the procurement request for the printing of Compendium 2017 was approved by the Head of the Procuring Entity, with Public Information and Assistance Division (PIAD) as the end-user as per Purchase Request No. 2018-0074;

WHEREAS, the Revised 2018 Annual Procurement Plan (APP) of NPC-PIAD includes an allocation for the printing of NPC Compendium 2017 amounting to Php990,000.00 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of SVP for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted on June 9, 2018 the request for quotation (RFQ) in the Philippine Government Electronic Procurement System, NPC Website and bulletin board, and sent RFQs to Gorilla Trading, Erzalan Printing Press and VJ Graphic Arts, Inc.;

WHEREAS, upon the deadline for submission of quotation on June 13, 2018, the NPC BAC Secretariat opened the quotations received, both solicited and unsolicited, and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Gorilla Trading tendered the Single Calculated and Responsive Quotation in the amount of NINE HUNDRED NINETY THOUSAND PESOS ONLY (Php990,000.00);

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the NPC Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the printing of NPC Compendium 2017 to "GORILLA TRADING" in the total amount of Php990,000.00.
