RECOMMENDING THE AWARD OF CONTRACT FOR ANNUAL PHYSICAL AND HEALTH EXAM (ENHANCE)

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC is mandated to administer and implement the provisions of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, pursuant to Civil Service Commission Memorandum Circular No. 33 s. 1997 "Policy on Working Conditions at the Workplace", CSC-DOH-DOLE Joint Memorandum Circular No. 1 s. 2020 "Occupational Safety and Health Standards for the Public Sector", Privacy Commission Order 016 dated 30 September 2020 and Privacy Commission Order 001 s. 2021 dated 28 January 2021 "Annual Physical and Health Exam Program of the NPC" shall be provided to serve as a tool to monitor the health status of its employees;

WHEREAS, to implement the same, there is a need to engage the services of a private healthcare and medical laboratory facility;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2020 Continuing Appropriations (RA 11520), programmed under the NPC FY 2020 APP-Continuing with Item No. 2020-0162 and with an Approved Budget for the Contract (ABC) amounting to Php680,000.00;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website, NPC website, and the NPC bulletin board, and was likewise sent to suppliers via electronic mail, namely: Fortmed Medical Clinics Makati, Inc., Asia Pacific Medical & Diagnostics Inc., Best Diagnostic Corp., AP Global I.T. Solutions, Clearbridge Medical Philippines Inc., and Philippine Vision Group (PVG);

WHEREAS, only Fortmed Medical Clinics Makati, Inc. submitted a quotation at the price of Php619,180.00. The BAC then, upon evaluation of the eligibility documents submitted, found that it is compliant and eligible, making it the single calculated and responsive bid;
