**RECOMMENDING THE AWARD FOR THE  
PUBLICATION OF NPC CIRCULAR/ ADVISORY (2 NEWSPAPERS)**

---

**WHEREAS**, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

**WHEREAS**, pursuant to Section 7 of the DPA, the NPC, through the Privacy Policy Office (PPO), aims to publicize in two (2) newspapers of general circulation the publication of its Circular on Guidelines on the Processing of Personal Data During Public Health Emergencies for Public Health Measures, to raise awareness among the public, government and private sector;

**WHEREAS**, to be effective and binding, the NPC Circular/ Advisory should be published in two (2) newspapers of general circulation;

**WHEREAS**, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the Annual Procurement Plan (APP) under APP Item No. 2021-0168 with Negotiated Procurement through Scientific, Scholarly, Artistic Work, Exclusive Technology and Media Services as the mode of procurement, and an Approved Budget for the Contract (ABC) amounting to Php250,000.00 for the two (2) newspapers;

**WHEREAS**, based on the conducted market study previously conducted by the end-user to determine the probable sources, Philippine Daily Inquirer, Inc. and Philstar Daily, Inc., being technically, legally and financially capable, have the widest circulation nationwide and have the capacity to undertake the project at a more advantageous terms;

**WHEREAS**, BAC proceeded to negotiate with the said suppliers based on the Technical Specifications prepared by the end-user;

**WHEREAS**, the BAC members proceeded to evaluate the submitted quotation and eligibility documents and determined that Philippine Daily Inquirer, Inc. and Philstar Daily, Inc. all passed the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act, at the bid price of Php97,675.20 and Php140,000.00, respectively, all terms being most favorable to the government;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) for his consideration and approval, the award of contract for the
