BAC Resolution No. 110-2021, Series of 2021

RECOMMENDING THE AWARD FOR THE PUBLICATION OF NPC PHILIPPINE PRIVACY TRUST MARK DPPMS (DATA PRIVACY AND PROTECTION MANAGEMENT SYSTEM) REQUIREMENTS

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, the NPC's Philippine Privacy Trust Mark intends to evaluate an organization's demonstration of operational compliance with the DPA and of having the proper organizational, physical, and technical security measures, and help organizations add value to their operations and establish trust with both of their external and internal clients, among others;

WHEREAS, in order to be widely circulated, the publication of the NPC Philippine Privacy Trust Mark DPPMS Requirements has been recommended to be published in three (3) newspapers of general circulation;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the Annual Procurement Plan (APP) under APP Item No. 2021-0163, with Negotiated Procurement through Scientific, Scholarly, Artistic Work, Exclusive Technology and Media Services as the mode of procurement, and an Approved Budget for the Contract (ABC) amounting to Php320,000.00 for the three (3) newspapers;

WHEREAS, Section 53.6 (e) of the Revised IRR of Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act provides that goods and services can be contracted to a particular supplier if the requirement is for media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media. Further, it is provided that due to the nature of the information to be disseminated, alongside principles of transparency, efficiency and economy, award to more than one (1) supplier may be made by the Procuring Entity.

WHEREAS, based on the market study previously conducted by the end-user to determine the probable sources, herein attached as ANNEX A, the providers who were determined to have the capacity to undertake the project at a more advantageous terms and are technically, legally and financially capable are Philippine Daily Inquirer, Inc., Concept and Information Group, Inc., and Philstar Daily, Inc.;

WHEREAS, the BAC proceeded to negotiate with the said suppliers based on the Technical Specifications prepared by the end-user;

WHEREAS, upon evaluation of the submitted quotation and eligibility documents, it was determined that Philippine Daily Inquirer, Inc., Concept and Information Group, Inc. and Philstar Daily, Inc. all passed the technical, legal and financial requirements mandated under R.A. 9184 at the bid price of Php97,675.20, Php70,761.60, and Php140,000.00, respectively, all terms being most favorable to the government;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) for his consideration and approval, the award of contract for the Publication of NPC Philippine Privacy Trust Mark DPPMS (Data Privacy and Protection Management System) Requirements in the total amount of THREE HUNDRED EIGHT THOUSAND FOUR HUNDRED THIRTY-SIX PESOS AND 80/100 ONLY (Php308,436.80), broken down into the following:
