TERMS OF REFERENCE

Procurement of VAW Polo Shirt and Caps for the Conduct of 18-Day Campaign to End Violence Against Women and Children (end VAWC)

November 25 - December 12, 2020

I. Background

As indicated in the Terms of Reference relative to the conduct of 18-day campaign to End VAWC, this is one of the activities under the NPC Annual GAD Plans and Budget for CY 2020. This is an 18-day campaign and regularly undertaken every year by all government agencies and instrumentalities following the directive from the Philippine Commission on Women and as mandated by Proclamation No. 1172, s. 2006. Also, Republic Act No. 10398 or the Act Declaring November 25 of every year as the National Consciousness Day for the Elimination of VAWC mandated government agencies to raise awareness on the problem of violence and the elimination of all forms of violence against women and girls. The activity starts from 25 November to 12 December 2020.

End VAWC is an advocacy campaign and supported by the United Nations (UN) Declaration on the Elimination of Violence against Women which defines it as "one of the crucial social mechanisms by which women are forced into a subordinate position compare with men."


Amnesty International often referred to VAW as "hidden epidemic" which spreads through social, cultural, and ethnic areas. All forms of violence and the threats of violence can be experienced by every woman of any age, skin color, gender identity, ethnicity, religion, disabilities, economic, and social status.

The 18-Day Campaign to End VAW supports the Philippine government's goal of protecting the human rights of women and girls by upholding its commitment to address all forms of gender-based violence as enshrined in the 1987 Constitution

As a form of advocacy campaign, the purchase of one (1) lot (minimum of 180 sets) polo shirts and caps for NPC employees composed of the following items will be used in observance of 18-Day Campaign to End VAW.
