TERMS OF REFERENCE

CONFERENCE SYSTEM (1 LOT)

I. BACKGROUND

The National Privacy Commission intends to procure one (1) lot Conference System. Based on several coordination with the suppliers, purchasing of the said system is more advantageous because can link various people in the organization through audio conferencing sessions. This eliminates the need for travel, making them both cost-effective and time-saving.

II. TECHNICAL REQUIREMENT

One (1) lot of Conference System composed of the following:

Professional Conference Desktop Wireless Microphone with 12 units

- This wireless gooseneck microphone system includes conference microphones and racks mountable receiver unit.
- Adopts UHF frequency band to avoid interference; channels and dual antenna design ensure clear and stable signal transmission.
- Each conference microphone has its own volume control knob on the receiver unit for adjusting the volume of the microphone separately to get desired vocal volume.
- The receiver has a 6.35mm audio mixing output to connect to speaker, and balance XLR outputs for long distance connection to reduce the noise.
- The microphones and receiver both have LCD display showing the working information, which is helpful for you to use and adjust the microphone system.

- Gesture-based, multitouch-capable capacitive touch screen
- 5-inch color LCD (720 x 1280 pixel), 9:16 aspect ratio
- On-screen virtual keyboard
- 1 USB 2.0 Type A-compliant port USB battery charging BC1.2 compliant (requires full Class 4 power input on LAN IN for operation)
- Must have Bluetooth and NFC capabilities
- 3 multicolored capacitive-touch mute indicators
- Unicode UTF-8-character support
