TERMS OF REFERENCE
FOR THE PROCUREMENT OF NPC MASCOT, CUSTOMIZED

I. Background

The National Privacy Commission (NPC) is tasked to inform and educate the public about data privacy, data protection, and fair information rights and responsibilities, as provided in Section 9.c of the Implementing Rules and Regulations of R.A. 10173 or the Data Privacy Act of 2012. One of the programs that the Commission implements to achieve maximum awareness is its PRIVACY, SAFETY, SECURITY, and TRUST (PSST!) campaign which is conducted online and in different regions nationwide since 2018.

The campaign aims to gather and engage with the Filipino youth by spreading awareness about data protection in different parts of the country; providing information on the risks, threats, and harms in the digital world; and promoting the culture of privacy to the society. To support effective communication to the data subjects, the mascot that will represent NPC's virtual assistant, namely Priva during events.

II. Objectives

The mascot will serve as the brand ambassador of the National Privacy Commission symbolizing the spirit of the agency. Eventually, it will become an icon that will help data subjects and stakeholders remember their roles and responsibilities in data privacy and data protection.

Procuring a mascot to promote the agency and its mandate is more economical and cost effective than hiring celebrity ambassadors during events.

The mascot will primarily be used during PSST! Campaigns which can be done online and offline. During physical events, the mascot will help capture the attention of the audience, particularly the youth. Similarly, online events can feature the mascot when presenting materials relevant to data protection of the youth. Aside from being used during PSST! Campaigns, the mascot will also be present during NPC privacy awareness advocacy roadshows, and other related events to engage stakeholders in a personal level.
