TERMS OF REFERENCE PAW2021 AWARDS (TOKENS / PLAQUES)

I. BACKGROUND

Pursuant to Proclamation No. 527 dated 03 July 2018, the National Privacy Commission will be conducting the 4^{th} Privacy Awareness Week (PAW 2021) on 24 – 28 May 2021. The PAW 2021 one of the commission's initiatives in raising awareness among our Filipinos and the Global Audience on the country's current data privacy practices and development.

In this regard, the PAW 2021 will be having an Awards Selection committee to aid in conducting competence related activities. The Awards Selection Committee is the award giving and competence development body of the Privacy Awareness Week 2021 through creating programs applicable to the said event in recognizing Filipino individuals and Filipino organizations who has excelled in the field of Data Privacy and Data Protection. The said committee will be having (1) Awards Nomination to conduct nominations and criteria reviews for Privacy Awards or Titles and (2) Privacy Competence Development Committee to conduct competitions and criteria assessment on skills applied and correlated to Data Privacy and Data Protection.

Moreover, the Commission shall ensure that this Event shall be a gender equitable and inclusive event. Notes on inclusive language and methods to emphasize the diversity of voices present shall be applied.

II. OBJECTIVES OF THE PROCUREMENT

In support of the mandate of the Commission, this procurement's main objective is to be a tool to promote preemptive privacy practices from organizations. This will serve as tokens of excellence in their efforts in implementing data protection among individuals.

This will serve as motivation to different entities to participate in the programs and initiatives of the NPC as an element in nation-building through data protection. Through these small gifts of appreciation from the Commission, they will be reminded of the work they have put to provide the public the service for their privacy

The objectives of the PAW 2021 Award are as follows:

- Distinguishes individuals and organizations who have excelled in data privacy and data protection related program or activities
- Evaluates nominations for the awards and presents the accepted nominations to the Chairperson for final selection of the awardees
