TERMS OF REFERENCE FOR THE PROCUREMENT OF THE PAW TSHIRT

I. BACKGROUND

The National Privacy Commission (NPC) is mandated to administer and implement the Data Privacy Act of 2012 (DPA). NPC is also tasked to inform and educate the public on data privacy, data protection, and fair information rights and responsibilities as stated in the Section 9.c of the Implementing Rules and Regulations of the DPA.

The Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the Commission. To fulfill these tasks, the division will develop, implement, and organize various activities, programs, and projects.

Since 2018, the NPC has been leading the national celebration of the Privacy Awareness Week (APW) in the Philippines every fourth week of May since 2018. It is essential that in celebrating this event, custom merchandise be available to engage more with audience, organizers, and staff to help them showcase their support, and have them serve as commemorative items.

In this regard, the division proposes to procure PAW tshirts to be distributed to various participating schools and organizations throughout the campaigns.

II. PURPOSE OF THE PROCUREMENT

PAW tshirts are part of the event's custom merchandise which have served as necessary additions since PAW's very first launch. They support the event's cause and help uplift the spirit and energy of participants in celebrating PAW.

Having customized shirts is a marketing strategy: they help generate awareness and hype as people wearing them become "walking billboards" that contribute to the publicity of the event. Compared to most traditional marketing tools such as newspaper ads, printing custom shirts is relatively inexpensive and yields benefits for an extended period – as long as people wear the shirt, the brand gets publicity.
