**RECOMMENDING THE APPROVAL OF THE REALIGNMENT OF THE ANNUAL
PROCUREMENT PLAN FOR CY2019 OF THE NATIONAL PRIVACY
COMMISSION**

WHEREAS, Section 7.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as Government Procurement Reform Act provides that all procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity;

WHEREAS, Item 3.5 of the Government Procurement Policy Board (GPPB) Circular 09-2015 dated 18 August 2015 identified Lump-Sum Appropriations and Centrally Managed Items (CMIs) as those items in the budget of Agencies for which the Implementing Units and specific amounts allocated for each have not been identified in the NEP or the GAA;

WHEREAS, to carry-out the Commission's mandate to administer and implement the Data Privacy Act of 2012, and to monitor and ensure compliance of the country with international standards set for data protection, the Compliance Monitoring Division (CMD) and the Human Resource Development Division (HRDD), requested to the Head of the Procuring Entity (HoPE), which the latter approved, the following changes to be effected in the Annual Procurement Plan for CY 2019:






