SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE RENTAL OF LED WALL FOR THE PRIVACY AWARENESS WEEK (PAW) TO CROSSFADE VIDEO ALTERNATIVES

**WHEREAS**, the procurement request for the LED Wall for PAW event to be held on May 28-29, 2018 was approved by the Head of the Procuring Entity, with the Office of the Privacy Commissioner as end-user, per P.R No. 2018-0047;

WHEREAS, the revised 2018 Annual Procurement Plan of NPC includes an allocation for the rental of LED Wall for PAW amounting to Php60,000.00 and the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of SVP for procurement of goods not covered by Shopping where the amount does not exceed One Million Pesos (PhP1,000,000.00);

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat posted in the PhilGEPS and NPC Website the Request for Quotation (RFQ) on May 22, 2018, and also sent on the same date the RFQ to Crossfade Video Alternatives, Business Unusual Media Solutions, Inc., and Red Root Artists Cooperative;

WHEREAS, upon the submission of quotation on May 25, 2018, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements and on the abovementioned date, Crossfade Video Alternatives was able to comply with the abovementioned requirements;

WHEREAS, based on the evaluation, the NPC BAC determined that Crossfade Video Alternatives tendered the Single Calculated and Responsive Quotation in the amount of FIFTY-SIX THOUSAND PESOS ONLY (Php56,000.00);


