SUBJECT: RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF OFFICE EQUIPMENT AND SUPPLIES TO SILENT WORKER MARKETING

WHEREAS, the procurement request (PR) for the delivery of office equipment and supplies was approved by the Head of Procuring Entity, with the Administrative Services Division (ASD) as the end-user, as per Purchase Request No. 2018-0062;

WHEREAS, the revised 2018 Annual Procurement Plan (APP) of NPC-ASD includes an allocation for the delivery of office equipment and supplies amounting to Php6,775.78 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, Section 53.9 the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) recognizes the use of Small Value for procurement of goods not covered by Shopping under Section 52 of RA 9184 and its IRR where the amount does not exceed One Million Pesos (Php1,000,000.00)

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat sent RFQs on June 11, 2018 to Silent Worker Marketing, Trojan Marketing, and IJA Enterprises;

WHEREAS, upon the deadline for submission of quotation on June 14, 2018, the NPC BAC Secretariat opened the quotations received and proceeded to evaluate the offers for compliance with the legal, technical, and financial requirements;

WHEREAS, based on the results of the evaluation, a copy of which is attached hereto as Annex "A", the NPC BAC determined that Silent Worker Marketing tendered the Single Calculated and Responsive Bid Quotation in the amount of SIX THOUSAND FOUR HUNDRED FORTY PESOS ONLY (Php6,440.00)

NOW, THEREFORE, for and for consideration of the foregoing, WE, the members of the NPC bids and Awards Committee, hereby RESOLVED, to recommend the award of contract for the delivery of office equipment and supplies to "SILENT WORKER MARKETING" in the total amount of Php6,440.00 for Seminar/Training on Rules Governing Security of Classified Matter in Government Offices;
