I. BACKGROUND

The National Privacy Commission (NPC) is tasked to educate the public about data privacy, data protection, and fair information rights and responsibilities, as provided in the Data Privacy Act of 2012 and its implementing rules and regulations.

The Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the Commission. The division has been developing, implementing, and organizing various activities, programs, and projects to fulfill these tasks.

By virtue of Proclamation No. 0527 issued by the President of the Philippines on 03 July 2018, the NPC has been leading the national celebration of the Privacy Awareness Week (PAW) in the Philippines every fourth week of May. The goal of NPC in celebrating this event is to impart the importance of protecting privacy and engage the stakeholders with the Commission's programs for broader impact.

Thus, through PIAD, the NPC conceptualized that custom merchandise be available to engage more with the audience, organizers, and staff to help them showcase their support and have them serve as commemorative items. Custom merchandise is also a great way to ensure that privacy remains at the forefront of our stakeholders' minds.

II. OBJECTIVES

The PAW tokens are part of the event's custom merchandise which have served as necessary additions since PAW's very first launch. They support the event's cause and help uplift the spirit and energy of participants in celebrating PAW.

Having customized tokens is a marketing strategy that helps generate awareness about NPC and hype as people using them contribute to the event's publicity. Compared to most traditional marketing tools such as newspaper and TV ads, procuring tokens is more useful, relatively inexpensive, and yields benefits for an extended period.
